In the reference fifth cited, the Secretary to Government, P&AR (A), Department, Secretariat, Chennai has stated that the Government of Tamil Nadu have issued orders/instructions to all Heads of Departments so as to emphasize that all the Government Servants, shall wear photo identity card compulsorily during office hours without fail. Even though orders/instructions have been issued, it is learnt that some of the departments have not followed the instructions scrupulously.

2. In the reference first to fourth and sixth cited various instructions were issued to employees of the erstwhile TNEB, now TANGEDCO, TANTRANSCO and TNEB Ltd. to produce the identity card as and when requested by the security officers.

3. It is therefore, instructed that all the officers/staff of TANGEDCO/TANTRANSCO/TNEB Ltd. should compulsorily wear the Identity Card without fail.

4. The above instructions should be adhered strictly.

5. The receipt of Memorandum should be acknowledged.
