The Hon'ble Madurai Bench of Madras High Court, while considering a case relating to Madurai Corporation in W.P. (MD) No.4095 of 2019, suspecting instances of malpractices indulged by Government servants in obtaining Law Degree, in its interim order, dated 02.04.2019, was pleased to order as follows :-

"4. This Court suo motu impleads the Chief Secretary, Government of Tamil Nadu St.George Fort, Chennai as 15<sup>th</sup> respondent. Mr.A.K.Baskarapandian, Learned Special Government Pleader takes notice for the 15<sup>th</sup> respondent.

5. The 15<sup>th</sup> respondent is directed to give report as to how many persons in absentia got law degrees in various departments and how many persons have got promotions by obtaining law degrees while working in the department. (Department wise details have to be given).

2. Pursuant to the same, the Government in the letter cited have called for an immediate report in respect of the TANGEDCO/TANTRANSCO so as to incorporate the same in the counter affidavit to be filed in the above Writ Petition.

3. Therefore, the Secretary, Chief Engineers, Chief Financial Controller, Chief Internal Audit Officer and Superintending Engineers, of the TANGEDCO/ TANTRANSCO, as the case may be, are requested to send a report in the format enclosed in respect of employees/officers under their control who have been in possession of a Law Degree **immediately, in any case, on or before 31.08.19 – 5.15 PM.**

4. If no such employee with a Law Degree is found working under their control, a "**NIL**" report should be sent to this office by 31.08.19 – 5.15 PM.

5. The Senior Administrative Officers of the Region or Thermal Stations, as the case may be, shall supervise the same and ensure that a report/NIL report in respect of the Circles/Station reaches the undersigned in time.

6. If a report/NIL report is not received before 31.08.2019 – 5.15 PM, it will be deemed that no such employee/officer having a Law Degree is working under your control and, accordingly, a report will be sent to Government. At any later date, if it is found that any such employee/officer is still found to be working with a Law Degree but the details are omitted to be furnished, the Senior Administrative Officer or Administrative Officer or Assistant Administrative Officer or such other Officer entrusted with the responsibility, as the case may be, will be held responsible for the same.
