PROCEEDINGS:-

Under regulation 92 of the Tamil Nadu Electricity Board Service Regulations read with the Tamil Nadu Electricity (Re-organisation and Reforms) Transfer Scheme 2010, Tmt.M.Chitra, Superintending Engineer/Mechanical is promoted and appointed as Chief Engineers/Mechanical in Division-I, Class-I of Tamil Nadu Generation and Distribution Corporation Limited Service with effect from the date of assumption of charge.

The official mentioned in para-1 above is instructed to furnish the Performance Assessment Report of himself together with the Performance Assessment Report of all Class-I Officers working under their control before their relief from the old station on Promotion without fail and the above individual is also instructed to send certificate to Secretary/Tamil Nadu Generation and Distribution Corporation Limited, to that effect.

The official mentioned in para-1 above is requested to return the option format duly filled in within one month from the date of promotion and assumption of charge. If the option format is not received within the said period of one month, her pay in the higher post will be fixed as specified in para-3 of Board's Memo. No.75406/P1/90-1, dated 19.3.1991.
