3. All the staff of the TANGEDCO and TANTRANSCO are instructed to be present in the office by 10.30 A.M. on all working days from 28.06.2019.

4. During the period of Assembly Session, undertaking of tours may be avoided. In exceptional circumstances, the officers concerned should obtain prior approval of the Chairman-cum-Managing Director and Directors concerned.
