Sub: Electricity – Online application filing of New LT Industrial service connection through web portal-Mandated -Reg.

Online application filing procedure in respect of LT service connection (except hut and agriculture) has been in vogue since 05.08.2016.

The Department of Industrial Policy and Promotion (DIPP), Government of India has recommended to implement a system that allows online application submission, payment and tracking of application status without the need for a physical touch point in obtaining new electricity connection. It also mandates that all applications are submitted online for obtaining new electricity service connection under Ease of Doing Business (EoDB).

To implement the above recommendation and to have easy access to the intending industrial applicants by eliminating physical touch point in document submission for availing new service connection, the Online application filing of new service connection in respect of LT Industrial applications shall be mandatory with effect from 01.07.2019.

In this process, the applicant has to upload the application and documents as per the provisions in the TNE Distribution Codes and no hard copies shall be insisted from the applicant.

In view of the above, it is hereby instructed that all the Chief Engineers/Distribution, Regions and Superintending Engineers /EDCs are requested to instruct the officials under their Jurisdiction upto the level of section officers to receive and process the LT Industrial applications through Online only.

If any applicant applies in person for the service connection, they shall be guided properly for applying the application through Online only.

In this regard, a nodal officer may be nominated to monitor /confirm that the LT industrial applications have been applied through online only.

It is also instructed to give wide publicity on the implementation of compulsory Online application filing, especially by displaying banner/Boards in all the TANGEDCO offices viz. section, sub-division, division, circle, regional offices and all collection centers, so as to reach general public in large.

If any new LT Industrial application is found to be received and processed through offline (in person) during verification /by representation /on complaints, then the concerned officer will be held responsible and it will be viewed very seriously.
