With reference to your letter cited, I am to clarify that as per the clause-1 of the standard Terms and Condition annexed to the B.P. cited, reads as follows:-

- i. Deduction of Union subscription or donation can be effected from a person for one Union only. If written authorization from any employees is received in favors of more than one Union/ Association, the request shall be summarily rejected and no deduction shall be made from the salary of that employee.
- ii. Further, as per clause-4 reads as follows:-  
The request for deduction in writing from the Union Member should be submitted to the pay claiming officer before 15<sup>th</sup> of May every year. Requisitions received after 15<sup>th</sup> of May will not be taken into account. The authorization given shall continue to be in force until it is withdrawn or any change is proposed by the employee. However, such withdrawal/change can be made once in a year i.e., from 1<sup>st</sup> May to 15<sup>th</sup> May of each year.

2) Hence, I am to request you to act according to the above standard Term and Condition in the above matter.
