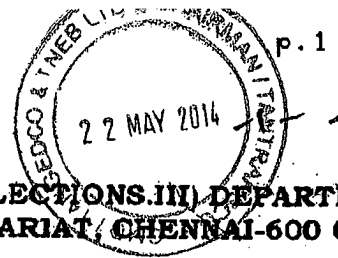


Sir / Madam,
