



**THE TRICHY REGIONAL LEVEL BRANCH SECRETARIES MEETING
HELD ON 13.11.2010 AT THIRUVARUR .**


THE FOLLOWING RESOLUTIONS WERE PASSED UNANIMOUSLY.


1. We request the Parent Body to represent the Chairman to avoid disturbing Transfer of Engineers to various Places in order to accommodate another Engineer.
2. We request the Parent Body to represent the Chairman for Direct Recruitment of Graduate Engineers as per work norms and there by reducing the work pressure of the existing Engineers.
3. We request the Parent Body to represent the Chairman to arrange to fill up the Vacant posts then and there.
4. We request the Parent Body to represent the Chairman to early implementation of One man commission's report .
5. We request the Parent Body to represent the Chairman to enhance the ceiling limit of traveling allowance for all Engineers @ 10% of the Pay.
6. We request the Parent Body to represent to the Chairman to fill up the Director (Distribution)/TANGEDCO as early.
7. We request the Parent Body to represent the Chairman to lift the condition of minimum service of one year for the promotion to the post of Chief Engineers.
8. We request the Parent Body to represent the Chairman to improve the performance of M/s. Gemini communications in Project BEST as the present performance of the above company in maintaining network and equipment is not satisfactory.
9. We request the Parent Body to represent the Chairman to provide Internet facility up to section level.
10. We request the Parent Body to represent the Chairman to provide Vehicle to all AEEs / EEs(Distribution).


11. We request the Parent Body to represent the Chairman to enhance the CUG phone ceiling limit to all AEE/AEs of TANGEDCO including those who are holding office posts and payment of CUG bill directly through Imprest.
12. We request the Parent Body to represent the Chairman to revise the monthly Remote allowance and annual incentive allowance to all Hydro / Gas generating station.
13. We request the Parent Body to represent the Chairman to carry out the special schemes like RAPDAP, Efficient motor replacement, effecting of Agl Services connection (2Lakhs) etc., through third agency without insisting to the existing employees.
14. We request the Parent Body to represent the Chairman to implement the TIME BOUND promotion which is a very long pending issue.

17. We request the Parent Body to convene emergency GC meeting to discuss various burning issues .


